Phillip Thomas Addington, Sr., 73, husband of Linda Lou Tew Addington, of Seneca, passed away on Wednesday, February 2, 2022, at Oconee Memorial Hospital.

Born in Spartanburg and raised in Cowpens, SC, Mr. Addington was the son of the late Julian Furman and Virginia Mae Thomas Addington. He was in the U.S. Army and served in Korea. Mr. Addington was an Administrative Law Court Judge for the State of South Carolina. He was a member of College Street Baptist Church where he served as a Deacon.
